AWARD CATEGORIES 2024

This year, we are inviting nominations in seven categories. Details of which are below:



Volunteer Group of the Year: Celebrating a group or voluntary organisation that has shown outstanding commitment to community service or enhancing Blaenavon's reputation in 2023/2024.



Business of the Year: Recognising a business that has positively impacted the Blaenavon community through initiatives, volunteering, sponsorship, or promoting welfare.



Sports Excellence Award: Recognising outstanding achievements in sports by individuals, teams, or coaches.



Arts and Culture Award: Recognising excellence in arts, literature, music, or heritage.



Youth Award: Recognising outstanding achievements by young people under 18 years.



Environment Award: Recognising exceptional efforts in environmental work.



Outstanding Contribution to Blaenavon: Recognising contributions that have had a significant impact on individual organisations, groups, or the town in general.

NOMINEE CRITERIA

To be eligible for an award, the nominee must:

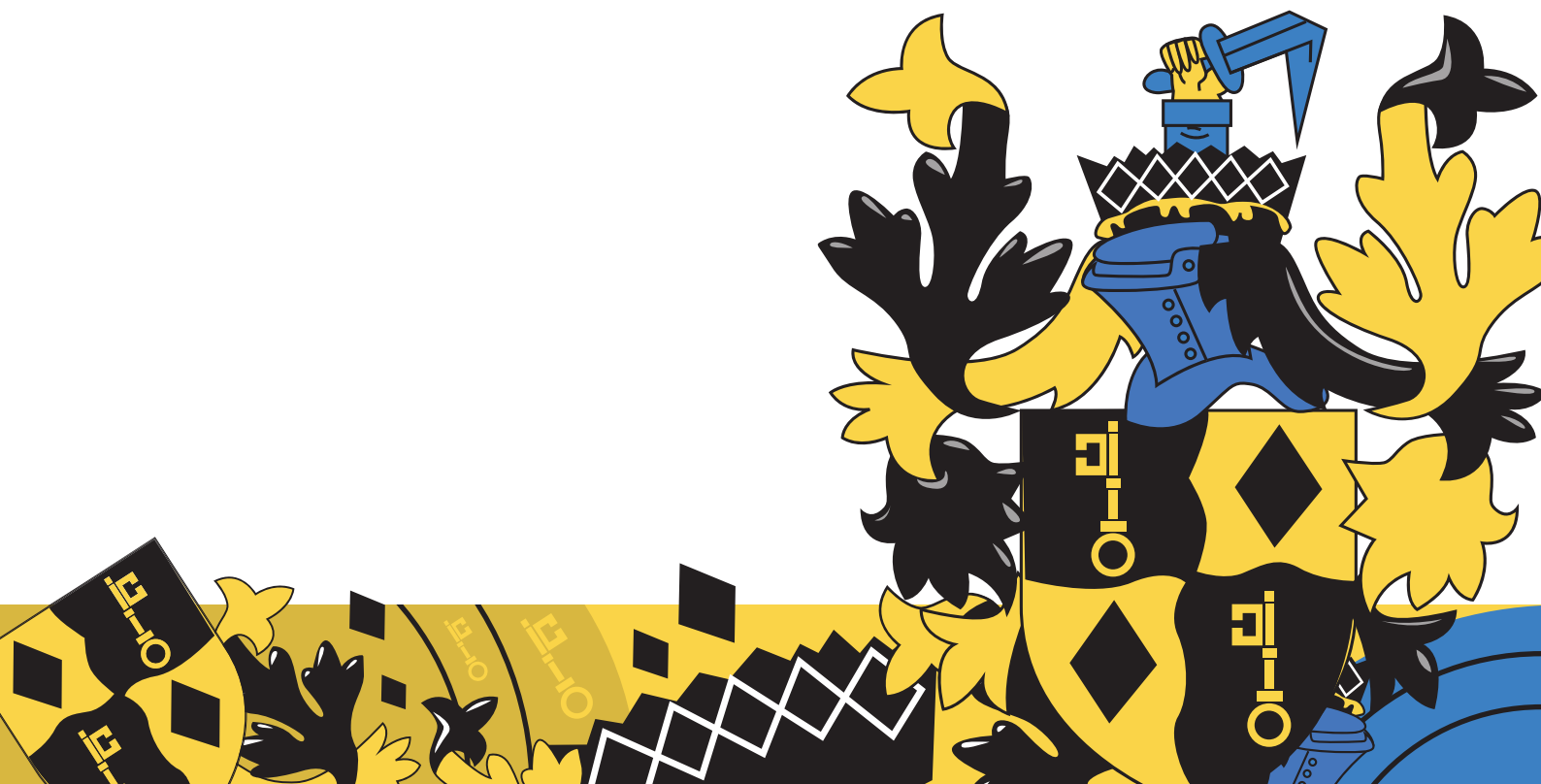
- Live within Blaenavon; **OR**
- Represent an organisation based in Blaenavon, **OR**
- Be involved in voluntary work within Blaenavon, **OR**
- Have made a significant impact in Blaenavon in the category in which they are nominated.

Eligibility Restrictions:

- Nominees must not be serving members or officers of Blaenavon Town Council.
- Nominees must not have received a Blaenavon Civic Award in the previous five years.
- For nominees in paid employment relating to the category in which they are nominated, it must be show how their contribution to Blaenavon exceeds their job responsibilities.

Review and Decision Process:

- Nominations will be reviewed and approved by Blaenavon Town Council.
- Approvals will be based solely on the eligibility criteria and the reasons provided for the nomination on the nomination form.
- The decision of the Town Council is final.
- The Town Council reserves the right to change a nominee's nomination category if another is deemed more appropriate.
- The Town Council may choose not to issue an award in a category if no suitable nominations are submitted.
